- Event documentation factors and media concerns.

SESSION 2 - Days 2 & 3: Crowd Control Units & Rapid Response Teams:

- Recognition factors of tension, mob psychology & types, gang influence and racial factors in civil disobedience events & potential disturbances.
- Civil Disturbance & Riot Control Tactical Action Planning
- Extensive training in specific riot aerosol munitions, advanced less lethal munitions, and the S&S (shield & spray) concept with riot shields.
- Team training in marching, formations, movements, lines, and high-profile insertion into physically combative and potential riot areas.
- Intensive practical exercises and drills will be conducted with realistic situations, locations, and conditions.
